Martón Váró Completes Phase One of Annunciation Sculpture *Head of Virgin Mary Displayed; Ave Maria Foundation for the Arts Introduced*

The first sculpted block of marble for the Annunciation bas relief sculpture at Ave Maria University was presented to the community by sculptor Martón Váró on April 17 at 11:30 a.m. A group of more than 50 gathered to celebrate the completion of the first phase of work on the sculpture.

The marble block, which stands nearly eight feet tall and weighs approximately 12 tons, depicts the head, face and shoulders of the Blessed Virgin Mary at the point when the angel Gabriel announced that, with her consent, she would be the mother of Jesus Christ.

Fr. Robert Garrity, AMU Campus Minister, began the event with a prayer. President

Nick Healy expressed the awe anyone would feel at seeing the “concept of beauty breaking free” day by day on AMU’s campus. He also announced plans for the block to be moved to the plaza in front of Ave Maria Oratory and enclosed in a clear case for viewing and for protection from the weather, especially hurricanes. Sculptor Martón Váró will be in Italy over the summer to work on other pieces of the same sculpture.

Chancellor Thomas Monaghan also spoke at the event, boasting of the sculpture, “No knock on Notre Dame, but this’ll make the golden dome a distant second.”

Váró spoke only briefly, noting, “I would rather say with my work what I have to say.”

He invited the general public to come and watch him at work on AMU’s campus.

Michael Windfeldt, owner of Soleil Fine Arts of Naples, invited attendees to a special reception held later that evening at Galerie du Soleil in Naples, where the newly-formed Ave Maria Foundation for the Arts (AMFA) would be introduced. Windfeldt, also executive director of AMFA, discussed the foundation, its mission and its goals.
